The role of the proposed research

This is possible for him with the structural and functional specialties of his neurons in the brain centers, on the evolutionary front, the cranium size is rapidly expanding due to mutational rates of diverse brain centers, controlling the body and the social functions and attitudes to create and establish a feeling of universal oneness of human society. Thanks to the human genome it is producing 2 to 3% of the mentally retarded as against a good percent of normal humans. This low percent is not only due to genetic errors but also due to so many kinds of infectious diseases that the human embryo faces from the day of fertilization, or due to epigenetic factors on the chromosomes of the male and female genetic. Mental Retardation (MR) has been defined as a condition of arrest or incomplete development of brain centers connected to the various mental faculties of the child. According to American Association for the Mentally Deficient (1983) mental retardation refers to a significant sub-average general intellectual functioning existing concurrently with defects in adaptive behavior, which manifested during the developmental period. Accardo and Captue (1996) defined mental retardation as a condition characterized by cognitive limitation due to organic brain dysfunction. Seeta Sinclair (1998) described mental retardation as sub average intellectual function combined with subnormal adaptation to a person's surrounding. Mental retardation is often associated with substantial neural loss or damage and therefore it is not curable with modern or orthodox medicine or otherwise. Therefore, it is often advised that mentally retarded should be managed and tolerated in a most feasible way and attempts should be made to relatively reduce adverse impacts of mentally retarded as much as possible. Researchers suggest that the mental handicap is primarily to be accepted as sort of permanent disability of some structural and functional part(s) of the brain which perhaps might have occurred sometime during the autogenetic stages of the fetus in the uterus for which the actual causes so far could not be exactly traced and elucidated even by the experts in human medicine for possible care and prevention.

In the past years the fortunes and misfortunes of the retarded were guided by superstition, ignorance and fear, to many centuries with first record in Greece and Rome. A significant beginning in the evolution of positive social thought towards the mentally retarded was established in the 19th century and considered that the mentally retarded persons have also rights in the society. Sparked by the leadership of Izard, Sequin, Howe and others, the scientific enquiry succeeded superstition and fear through their pioneering efforts. Consequently, sound educational and training programs were developed to manage mental defects, and institutional facilities were established.

These techniques were applied largely to very retarded person, the major from of retardation identifiable at that time. Although program emphasis within the institutions was often merely custodian, a milestone has been passed in the acceptance of public responsibility for the retarded and the provision of human care for them in public support facilities were



earmarked.

Significance of the proposed research.

there has been increase in parents who have children with mental retardation, and research has become increasingly diverse. The causes of development of mental retardation are variedly related to factors of genetic inheritance or to the effects of the external environment and infection. This comes together with the impairment of the central nervous system, its different structure or different development, during the antenatal, prenatal or early postnatal period. The evolutionary concepts on human genome were considered important as compared to the other organisms. The useful change is adapted in the direction of better interaction with physical, chemical and biological environments. Changes are inevitable in different organs of human system to win over even adverse surroundings step by step through the process known as micro evolutionary changes. Apart from mutation and selection a third force in the genome is often referred as drift of genes in living systems which are non adaptive by nature fixing either recessive gene or the dominant gene.
